### What makes a quality information literacy programme?

- Collaboration with institution/faculty
  - institutional mandate, commitment and structure
- Articulation with the curriculum
  - librarian deeply familiar with the curriculum
  - librarian understands scholarly information patterns
  - library's goals synchronised with educational goals of institute
- Pedagogy and information technology
  - librarian full partner in delivery of educational content

### Veterinary Education in Finland

- College of Veterinary Medicine 1945-1995
- Faculty of Veterinary Medicine, University of Helsinki, 1995-
- 50 students/year
- 5 doctorates/year
- ca 8 specialists /year
- Continuing education (1500 veterinarians in Finland)
- New premises in Viikki Campus 2004
- More co-operation with the Faculties of Agriculture, Pharmacy and Biosciences of the University of Helsinki

### Strategy of the Faculty of Veterinary medicine

Responsible for

- basic and postgraduate education
- specialization programmes

Partly responsible for

• continuing education in cooperation with Länsi-Uusimaa Institute for Continuing Education, a unit of the Centre of Continuing Education at the University of Helsinki

Its library is responsible for instruction in information literacy preferably integrated in the education

### The Veterinary Medicine Library in Finland

- founded 1892 by the Finnish Veterinary Association (FVA)
- donated 1945 to the College of Veterinary Medicine
- librarian and library premises 1962
- to be merged to Viikki Science Library in 2004
- direct services to veterinarians all over Finland (distance between Helsinki and e.g. Utsjoki in Lapland is 1000 km, practitioners work mostly alone)
- collections focused on veterinary medicine and food hygiene
- inter-library-lending (ILL) is very well developed in Finland
- instruction in information literacy

### Information literacy instruction at the Faculty of Veterinary Medicine

Basic education

- introduction to library services (1 year)
- use of library services (PBL literature reviews, 1 year)
- information retrieval (short thesis 4-6 year)
- information retrieval-drop in courses( students and teachers)

Postgraduate education and faculty

- information retrieval, selected resources (special groups)
- information retrieval drop in courses (postgraduate students preparing thesis and teachers)

### **Teaching methods**

- traditional class room and hands on teaching
- team-teaching: two librarians, librarian faculty
- netbased courses; in cooperation with Viikki science library

### Information literacy for practicing veterinarians

- integration with courses organized by the Länsi-Uusimaa Institute for Continuing Education, a unit of the Centre of Continuing Education at the University of Helsinki
- user education courses organized together with Finnish Veterinary Association (day after Annual Finnish Veterinary Conference)
- courses organized specially for municipal veterinarians
- hands on instruction of veterinarian visiting the library

### **Teaching methods**

- Traditional classroom teaching -at the Faculty, at the premises of the course organiser
- Netbased courses

### Why netbased information literacy instruction ?

New era:

- nearly every veterinarian has access to internet
- numerous electronic resources available (for free or licensed)
- supported by faculty and other partners of continuing education (economic support during the project phase)

# Solution: The project "Improvement of the practising veterinarian's information literacy by netbased education"

## One portal

- that supports different groups of practising veterinarians
- gives a clear picture of available quality resources and teaching material
- gives efficient information searching possibilities

### Netbased courses

- to support retrieval of information e.g. via the portal
- as part of the continuing education programme of the Faculty of Veterinary Medicine

### Continuing education programme for practicing veterinarians

- Organizers: the Länsi-Uusimaa Institute for Continuing Education, a unit of the Centre of Continuing Education at the University of Helsinki, the Faculty of Veterinary Medicine, the Veterinary Medicine Library
- Sponsors: the Food and Health Department at the Ministry of Agriculture and Forestry in Finland
- Topic: Herd health management
- Length and duration: 20 credits, combination of modules, 2 years

### Project phases 1

Gathering of relevant information resources

- Cooperation with relevant producers of websites/information for veterinarians:
  - the Food and Health Department at the Ministry of Agriculture and Forestry in Finland
  - the National Veterinary and Food Institute
  - the National Food Agency
  - the Finnish Veterinary Association
- Analysis of the information needs of practising veterinarians:
  - administration, -production, -food industry (deep interviews)
- Collaboration with teachers of subject modules of the continuing education course

Design of a "one-stop-shop" portal

### **Project phases 2**

Design of netbased courses

- obligatory introductory course in information literacy for "Herd health management" (February 2003)
- obligatory course in information literacy for the module "Good veterinary practice (GVP) and legislation" of Herd health management (September 2003)

### Steps in netbased course design

- choice of the e-learning platform
- starting seminar in classroom and hands on -teaching
- net-based distant learning independently, supported by the library (email)
- closing seminar, feed-back and suggestions for further studies

### **Results and experiences**

- Comments on portal design
- Comments on netbased course design

### Skills required by library personnel

- Familiarity with production of netbased courses and pedagogical methods
- Knowledge of web design and updating
- Knowledge of internet resources in the field
- Familiarity with the curriculum
- Full member of the planning and teaching team
